

# Terms of Use

## 1.0 Acceptance of Terms

1.1 WonderfulQuote.com is a website that offers collections of quotations by author and by topic.

1.2 Diffen LLC, a Washington State LLC, makes WonderfulQuote.com, including all information and services on WonderfulQuote.com, available to you subject to the terms provided in this document (Terms of Use).

1.3 You accept these terms by accessing or otherwise using WonderfulQuote.com in any way. IF YOU DO NOT AGREE TO ALL THE TERMS IN THIS DOCUMENT, DO NOT USE WONDERFULQUOTE.COM.
